# **Business Financial Services Company Improves Employee Offboarding Accuracy and** Completeness, and Increases Efficiency with **Oomnitza ETM**

## Challenges

The business challenges that led the profiled company to evaluate and ultimately select Oomnitza:

- Before using Oomnitza's ETM Platform they had:

  - Inefficient, manual and error-prone tasks to complete regulatory, industry and vendor audits

### **Environment**
